

## SIE41N: Tunbridge-Peru-Wilmington complex, 3 to 8 percent slopes, rocky

The Tunbridge, rocky component makes up 26 percent of the map unit. The natural drainage class is well drained. Water movement in the most restrictive layer is low. This component is on hills, mountains. The parent material consists of loamy till. Depth to a root restrictive layer, bedrock, lithic, is 20 to 40 inches.

The Dixfield, rocky component makes up 24 percent of the map unit. The natural drainage class is moderately well drained. Water movement in the most restrictive layer is moderately low. This component is on hills, mountains. The parent material consists of loamy basal till. Depth to a root restrictive layer, densic material, is 20 to 36 inches.

The Wilmington, rocky component makes up 20 percent of the map unit. The natural drainage class is poorly drained. Water movement in the most restrictive layer is moderately low. This component is on hills, mountains. The parent material consists of loamy basal till. Depth to a root restrictive layer, densic material, is 10 to 20 inches.

## Vermont Residential Onsite Waste Disposal Group and Subgroup: IIIf

This unit is marginally suited as a site for soil-based residential wastewater disposal systems, based on a review by the Natural Resources Conservation Service of criteria set forth in the Vermont 2007 Environmental Protection Rules. The depth to the seasonal high water table and the restricted depth to bedrock in some areas are the major limitations. On-site investigations can help avoid areas with limited depth to bedrock. Additional fill material may be needed in some areas in order to meet the separation distance requirement between the bottom of the leachfield and bedrock. A detailed, site-specific analysis with groundwater level monitoring and determination of induced groundwater mounding may be required to establish the suitability of this unit. Mound system construction and other site modifications are often necessary. On sloping sites, curtain drains can help lower the water table to an acceptable level.
