

64D: Stockbridge gravelly silt loam, 15 to 25 percent slopes

The Stockbridge component makes up 80 percent of the map unit. The natural drainage class is well drained. Water movement in the most restrictive layer is moderately low. This component is on ridges on glaciated uplands, hills on glaciated uplands. The parent material consists of coarse-loamy till. Depth to a root restrictive layer is greater than 60 inches.

This unit is moderately suited as a site for soil-based residential wastewater disposal systems, based on a review by the Natural Resources Conservation Service of criteria set forth in the Vermont 2007 Environmental Protection Rules. The slow permeability in the substratum and slopes greater than 20 percent in some areas are the primary concerns. Mound system construction and other site modifications may be necessary. There may be less-sloping areas within the unit that are suitable for siting a septic system, or, if feasible, cut and fill site modifications may produce an acceptable area within the unit. An erosion prevention and sediment control plan is required by the State for construction on sites over 20 percent slope.
