

67D: Glover-Vershire complex, 15 to 35 percent slopes, very rocky

The Glover component makes up 45 percent of the map unit. The natural drainage class is somewhat excessively drained. Water movement in the most restrictive layer is low. This component is on hills on glaciated uplands. The parent material consists of coarse-loamy till. Depth to a root restrictive layer, bedrock, lithic, is 10 to 20 inches.

The Vershire component makes up 35 percent of the map unit. The natural drainage class is well drained. Water movement in the most restrictive layer is low. This component is on hills on glaciated uplands. The parent material consists of coarse-loamy till. Depth to a root restrictive layer, bedrock, lithic, is 20 to 40 inches.

This unit is marginally suited as a site for soil-based residential wastewater disposal systems, based on a review by the Natural Resources Conservation Service of criteria set forth in the Vermont 2007 Environmental Protection Rules. The depth to bedrock is the major limitation. On-site investigations are needed to locate areas with sufficient soil depth. A significant percentage of the soils in this unit are less than 18 inches to bedrock and are not suitable as a site. However, there may be deeper areas that are suitable. Additional fill material may be needed in some areas in order to meet the separation distance requirement between the bottom of the leachfield and bedrock.
